NOTICE TO EXHIBITOR

In the Notice all references to The Club will be to the Northern California Curly Coated Retriever Club

The safety of the dog is our primary concern. By entering this show, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all exercises safely. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The Club and/or agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations

The Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against FOF Event Services and/or the **The Club** or any official thereof.

All dogs must be on leash at all times when on trial grounds except when in the competition ring. Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs allowed in rings during judging only.

No entry shall be made and no entry shall be accepted which specifies any conditions for its acceptance. No entries will be accepted without fees, signatures or the "Agreement" on the reverse side of the OFFICIAL AKC ENTRY FORM.

A Recording Fee of 50 cents for each dog and an AKC Event Service Fee of \$3.00 will be required for each recordable single entry class at any Licensed or Member Club Show or Obedience Trial. (American Kennel Club Rule, Chapter 11, Section 2). A \$3.00 AKC Recording Fee will be required for each entry in Rally. (American Kennel Club Rally Regulation, Chapter 1, Section 3) These Fees are paid to the American Kennel Club.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee or by the American Kennel Club. There will be no refund for duplicate entries.

RETURNED CHECKS do not constitute a valid entry fee. Fees must be paid in guaranteed funds. The Show Secretary will add a collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis. There will be no refund for duplicate entries. **CANADIAN EXHIBITORS MUST SUBMIT ENTRIES WITH CHECKS DRAWN ON U.S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS**

Changes, additions or corrections to the entry form must be made in writing or by email. No telephone changes will be accepted. Proof of transmission of email is not proof of receipt by the Show Secretary. Refunds of \$5.00 & less will not be issued due to the costs of processing. An administrative fee of \$3.00 may be charged for cancellations or changes made prior to closing of entries.

Arbitration: This club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.
